

PARTNERSHIP AGREEMENT

The following agreement is made between Shaw, Bransford & Roth, P.C. (SB&R) and Federally Employed Women (FEW).

Partnership Terms

SB&R will provide to FEW:

- FEW members will receive two free half-hour telephone legal consultations, not on the same matter, annually from SB&R.
 - This arrangement only permits telephone consultations. If a member wishes to have an office consultation, she will be charged at the normal consultation rate. FEW members who retain SB&R after the consultation will still receive the 10 percent discount on attorney fees, not costs.
 - This consultation does not include document review.
 - FEW will provide SB&R with an electronic membership list sent monthly to verify membership.
- FEW members are entitled to a 10% reduction in attorney fees, not costs, if they retain SB&R to provide legal services.
- FEW will have a link included on the SB&R website, under the Consultation Process website.

FEW will provide to SB&R/FEDmanager:

- FEW will list SB&R on their website as one of FEW's Partners with link to the SB&R website.
- FEW will list FEDmanager on the Information of Interest webpage with link to the FEDmanager website.
- FEW will include an announcement to their members once a year in FEW's News & Views that explains the member benefit offered by SB&R.
- FEW will include an announcement to their members twice a year in FEW's News & Views that promotes FEDmanager as a free resource for FEW members.
- FEW will include a free SB&R advertisement in any course bulletin that is published for NTP.
- FEW will waive its exhibitor fee for SB&R to exhibit at its annual NTP.

This contract is valid from the date of execution until termination is provided in writing by one or both parties.




