Federally Employed Women's (FEW) Voting Record Scorecard for the 116th Congress—First Session

Dear FEW Members:

The One Hundred Sixteenth United States Congressional Session convened in Washington, D.C., on January 3, 2019, and will end on January 3, 2021, during the third and fourth years of the Presidency of Donald Trump. Senators elected to regular terms in 2014 are finishing their terms in this Congress and House seats were apportioned based on the 2010 Census.

In this FEW Scorecard during the 116th Congress are four recorded votes acted upon by the United States House of Representatives and two recorded votes in the United States Senate. As you are aware, we rate lawmakers based on their recorded vote on the bills that are identified in the three tiers of FEW's Legislative Agenda.

In this session members were scored on legislation that was considered to have an impact on federally employed women, the federal workforce, or in-line with issues that FEW has taken a supportive position. You will also note, that there are (2) bills that FEW supported, as "Key" votes, which were introduced and passed out of Congress!

Also, highlighted in this Scorecard are the Congressional Members in the United States Senate and United States House of Representatives who were in alignment with FEW on the legislative issues that received hearings in committee and votes in the House of Representatives. FEW extends a special "Thank-You" to these members for their support and to each of you for your advocacy engagement. Note: This list does not include all the legislators who have been and continue to support the issues that are important to FEW.

I encourage you to examine the current and past voting record of your own representatives for a detailed history on the issues that are a part of FEW's advocacy. Simply, look up your legislators and contact them about their votes and decisions regarding their votes and co-sponsorships. To find out who your legislators are, simply, visit ENGAGE tool on the FEW website and type in your zip code under the Elected Officials link.

While this voting record is an important tool in monitoring the actions of Congress, it is important to recognize that it is not the sole reflection of a legislator's record. Furthermore, it is neither an endorsement nor a condemnation of any Member of Congress.

To conclude, this year will be the end of my tenure as the 2018 - 2020 President of FEW. Through my presidency, I have experienced and advocated for legislation which I am very proud to have helped pass with all of your help, like: S.3749 - Congressional Accountability Act of 1995 Reform Act (2018); and H.R. 6147 - Appropriations Minibus [pay increase] (2018), and Federal Employee Paid leave (2019).

What I have come to appreciate the most -- is that FEW knows how to get the job done -- literally and figuratively. No words here could do justice to the gratitude and respect I have for all of you - members and non-members alike. It has been a great privilege to be part of an extraordinary organization at an extraordinary time. Thank you for allowing me to represent each of you.

FEW Tier Issues/Key Votes

(No Roll Call Votes on Final Passage Recorded)

Bills Introduced and/or Cosponsored

Equal Rights Amendment. Introduced by Rep. Jackie Spier - status of the Equal Rights Amendment (ERA) resolution [H.J Res. 38] that proposes an amendment to the Constitution relative to equal rights for men and women - a priority issue for FEW. There have been no roll call votes related to this resolution. Latest Action: 01/30/2019 Referred to the Subcommittee on the Constitution, Civil Rights, and Civil Liberties.

FEW POSITION: Yes

Equal Rights Amendment. Introduced by Sen. Ben Cardin - status of the resolution [S.J.Res. 6] that removes the deadline for state ratification of the Equal Rights Amendment (ERA) - a priority issue for FEW. There have been no roll call votes related to this resolution.

Latest Action (S.J.Res. 6): 01/25/2019 Read twice and referred to the Committee on the Judiciary.

FEW POSITION: Yes

Employment Benefits. Introduced by Rep. Gerald E. Connolly/Senator Chris Van Hollen

[H.R.790/S.262] - A bill recognizing the contributions of Federal employees with a 2.6 percent increase rate of basic pay for most federal civilian employees for 2019.

Latest Action [H.R.790]: 01/30/2019 On passed - *Passed the U.S. House of Representatives* by recorded vote: 259 - 161 (Roll no. 64).

01/31/2019 Received in the Senate

FEW POSITION: Yes

Employment Benefits. Introduced by Rep. Rosa DeLauro - status of the Paycheck Fairness Act [H.R.7] to provide more effective remedies to victims of discrimination in the payment of wages on the basis of gender.

Latest Action (H.R. 7): 03/27/2019 On passage - *Passed the U.S. House of Representatives* by the Yeas and Nays: 242 - 187 (Roll no. 134).

Latest Action: 04/03/2019 [Senate] Read the second time. Placed on Senate Legislative Calendar under General Orders. Calendar No. 53.

FEW POSITION: Yes

Employment Benefits. Introduced by Rep. Carolyn Maloney - status of the Paid Parental Leave Act [H.R.1534] to provide four weeks of paid leave to federal workers upon the birth or adoption of a child. There have been no roll call votes related to this bill.

Latest Action (H.R. 1534): 03/05/2019 Referred to the Committee on Oversight and Reform, and in addition to the Committee on House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

The some of the legislative language from H.R. 1534 that guaranteed federal employees 12 weeks of paid family leave was included in the National Defense Authorization Act, (NDAA).

FEW POSITION: Yes

FEW strongly urged Congress to reauthorize the Violence Against Women Act (H.R. 1585), on behalf of the health and safety of millions of women, men and their families.

FEW Position: YES

[2] H.R. 7 - Paycheck Fairness Act

March 27, 2019

Paycheck Fairness Act

Passed 242 - 187

(Dem: 235; Rep: 7) - (Rep: 187) (NV: 3)

FEW supports this bill which addresses wage discrimination on the basis of sex. It amends the equal pay provisions of the Fair Labor Standards Act of 1938.

FEW Position: YES

[3] H.R. 790 - Federal Civilian Workforce Pay Raise Fairness Act of 2019

January 30, 2019

Federal Civilian Workforce Pay Raise Fairness Act of 2019

Passed 259 - 161

(Dem: 230; Rep: 29) - (Rep: 161) (NV: 12)

FEW supports this bill which the rates of basic pay for federal civilian employees would increase by 2.6 percent for 2019.

FEW Position: YES

[4] H.R. 2500 - National Defense Authorization Act for Fiscal Year 2020

December 11, 2019

National Defense Authorization Act for Fiscal Year 2020

Passed 220 - 197

(Dem: 220) - (Dem: 8; Rep: 188; Ind: 1) (NV: 16)

FEW supports this bill which authorizes FY2020 appropriations and sets forth policies for the Department of Defense (DOD) programs and activities, including military personnel strengths. It included a Pay Raise for our Troops, Rebuilding our Military, Paid Parental Leave, Border Security, and Space Force.

This bill is particularly important to FEW because it provides parental paid leave to federal employees, who've been with the government for at least a year. It is the first major benefit expansion for federal workers since the 1993 Family and Medical Leave Act, which provides 12 weeks of unpaid leave. This bill was enacted after being signed by the President on December 20, 2019.

FEW Position: YES

Key to the FEW Scorecard: We scored four (4) House Votes. Each vote counts as 25% of the total score. A member will only receive 100%, if completely aligned with FEW's position on each vote. A non-voting member (NV) receives a 0 score for each bill FEW supports.

Government Employee Fair Treatment Act of 2019

FEW supports this bill requires employees of the federal government or a District of Columbia public employer who are furloughed or required to work during a lapse in appropriations beginning on or after December 22, 2018, to be compensated for the period of the lapse. The employees must be compensated on the earliest date possible after the lapse ends, regardless of scheduled pay dates. Employees required to work during the lapse in appropriations may use leave.

This vote was by a “**Voice Vote**” so no record of individual votes was made. This bill was passed by both chambers in identical form on January 11 and signed by the President on January 16.

National Defense Authorization Act for Fiscal Year 2020

Passed 86-8

(Dem: 37; Rep: 48; Ind: 1) - (Dem:4; Rep: 4) (NV: 6)

FEW supports this bill which authorizes FY2020 appropriations and sets forth policies for Department of Defense (DOD) programs and activities, including military personnel strengths. It does not provide budget authority, which is provided in subsequent appropriations legislation. However, it does include a Pay Raise for our Troops, Re-building our Military, Paid Parental Leave, Border Security, and Space Force.

This bill is particularly important to FEW because it provides paid parental leave to federal employees who've been with the government for at least a year. It is the first major benefit expansion for federal workers since the 1993 Family and Medical Leave Act, which provides 12 weeks of unpaid leave.

This bill was enacted after being signed by the President on December 20, 2019.
